In accordance to this document, I the signatory below, confirm, as I am one of the students attending the University of Bahrain, that my full allegiance is for the leadership of the Kingdom of Bahrain represented in His Majesty The King Hamad Bin Essa Al Khalifa, the King of the country may God guard and bless him and the wise government.

And I pledge to respect the laws and regulations of the Kingdom of Bahrain, and the laws, regulations and the provision lists of the University of Bahrain, that I have read (List of Misconduct for the students of the University of Bahrain), and pledge not to organise or participate in any event or activity that is not permitted or does not solely relate to the students or to their academic regards, inside the University campus or outside it, or events and activities that would harm the reputation of The Kingdom of Bahrain domestically and internationally.

And I am also fully aware that I only bear 6% of the total educational expenses which is about 200 Dinars annually, while the country bears 94% of the total educational expenses which is about 4000 Dinars annually.

Based on this, I acknowledge that not signing this document means I do not wish to continue my education in the University of Bahrain, and whereas if I do sign, I fully understand that if I committed any action that contradicts with any of the provisions of this document, the administration of the University of Bahrain will have the right to take any proceedings it sees suitable against me in terms of decrees and punishments that may reach a maximum of final and immediate suspension from the University of Bahrain.

List of Misconduct for the Students of the University of Bahrain

Article (2)

Any violation to the laws, provision lists, decrees and traditions of the University of Bahrain will be regarded as misconduct, and in particular the following:

- A- Acts that violate the regulations of the University, school, section, department or University facilities
- B- The planned refrain from attending the lectures, hindering the educational process or encouraging it.
- C- The refrain without permissible excuse from the tasks or other academic activities that the University regulations require and insist on.
- D- Cheating, taking initiative to cheat, or assisting others to cheat during examinations, researches, graduation projects, and higher education researches or breaching the examination regulations and the required silence during them.
- E- Breaching the required regulations required by the lectures and other academic activities at the University.
- F- Any insult, offence, or abuse from any student towards a member of the educational staff in the University, or to any of the employees or students.
- G- Any statement, or action by a student that offences honour, dignity or good conduct inside or outside the University, in any event that the University is participating in, or during any of its activities or during the use of the University transport.
- H- Any forgery to any of the University documents, or the use of these forged documents.
- I- Any distribution to publications, issuing of wall magazines in the schools, gathering signatures or charity without acquiring previous clearance to do so from the specialized department at the University, or any offence during the use of the granted clearance in practising the mentioned activities.
- J- Promoting to go against the legitimate institutions, or agitate the values of national unity.
- K- The promotion of any organisation inside the University, or participating in it without a previous clearance from the specialised University department. Or participating in any activity that breaches the regulative laws in the University.
- L- Not committing to a suitable dress-code, and known University traditions.
- M- Damaging University movable and un-movable possessions, or using them abusively.
- N- Protesting inside the University buildings, or participating in demonstrations without acquiring a previous clearance from the specialised University department.
- O- Causing any noise within the University campus.
